It was **resolved** to confirm that the Council had no objection to the proposal from Carmarthenshire County Council.

CLERK'S REPORT

a) Rights of Way

i) Maintenance contract

An invoice for £1905 had been received from Dynevor Tree Services for the 1st cut of the footpath maintenance for contracts nos 1 and 4-9. Additionally, a further invoice for £1230 had been received for extra work agreed by the Clerk and identified only when footpath clearance was being undertaken. All works had been satisfactorily completed and it was **resolved** to pay the invoice.

ii) Footpath 51/62

It had been previously reported that reports of damaged stiles had been received by the Clerk on various footpaths throughout the area. A broken stile on Footpath 51/62 had been satisfactorily replaced by R Gleaves at a cost of £40.00. Two further stiles had been provided for another local landowner for him to replace personally. It was **resolved** to pay the invoice.

iii) Footpath 51/36 at Caerbryn (Cae Steps)

The Clerk had agreed with Carmarthenshire County Council that this footpath would be cut following complaints from local residents that it had become overgrown in places. The footpath had never been part of the Community Council maintenance contract and provides direct access on to the land at Gilfach Iago. The County Council rangers could not guarantee the work being done quickly. The path had been satisfactorily cut by R Gleaves at a cost of £120 with no VAT charged.

b) Parks

i) Overhead rotator handle – Penygroes park

This item of equipment had been previously reported and identified as in need of replacement. The item had been procured from Fenland Leisure Ltd at a cost of £389 plus VAT to remove a Health and Safety concern on the inspection reports. It was **resolved** to pay the invoice. ii) Penygroes Community Centre

Councillor Mrs S.E Thomas informed Members that discussions were well advanced in agreeing a new tenancy for the Community Centre at Penygroes park.

c) Tree Surveys

Residual work identified from the reports had been costed with 3 quotations obtained and the contract awarded to R Gleaves of Bonllwyn at a cost of £550. Work will be undertaken in line with the recommendations of the reports. It was resolved to confirm the contract.

d) Wild Flowers

An invoice for £525 plus VAT had been received from Wrenvale Nurseries and Landscapes for wild flower planting agreed as part of the community development budget. It was **resolved** to pay the invoice.

Councillor Mrs C. Thomas asked that the contractor confirm with the Council that the seeds being used were British in origin for future planting.

e) Fire extinguisher checks

Annual checks have been undertaken at the office and pavilions by Gorlech Fire Protection at a cost of £139. It was **resolved** to pay the invoice.

e) Councillor expenses payments

In accordance with IPRW guidelines the annual paymnets have been processed and will be paid on the 31st July, 2021.

f) CCTV at Penygroes park

Following agreement to proceed with CCTV at the park, the Clerk had attended a webinar with Kate Harrop, Community Safety Manager at Carmarthenshire County Council. She confirmed that as a Community Council we are classed as a 'responsible authority' relating to CCTV in public spaces and there are extra responsibilities compared to business operated systems or home CCTV.

There is a duty to comply with the Home Office Surveillance Camera Code of Practice 2013 which includes the completion of a Data Protection Impact Assessment, liaison with the police and conducting a public consultation exercise.

The chosen contractor has been asked to delay any installation until the Clerk has completed his initial findings as to what is required from the Community Council to satisfy legislation.

Councillor R. A Davies questioned the cost and extra responsibility for the installation, and proposed that the project be cancelled and that the new tenants of the community centre should possibly be encouraged to install their own system which would help with the council's concerns at the park. A counter proposal from Councillor C.J Harris recommended that the process which had already started by the Clerk be continued, and that the Clerk report back to the September meeting before a definitive agreement is given to move forward with the installation. A vote of Members present agreed that the counter proposal be accepted by 7 votes to 3.

g) Local Places for Nature

One Voice Wales have appointed Rachel Carter as a Local Places for Nature Officer. This capital funded programme has been set up by Welsh Government to halt and reverse the decline of biodiversity in Wales. Her role is to help local councils facilitate new projects and she is initially looking for interested councillors to join a new fortnightly networking group to discuss environmental issues, share project ideas and achieving the Council's biodiversity action plan.

Councillors Mrs C. Thomas and Mrs S.E. Thomas agreed to attend the networking group as representatives of the Council.

h) Water Hygiene contract

Quotations had been sought from three companies who could undertake the water hygiene services at both pavilions and the public conveniences for a 2 year period with an option to extend for a further year if both parties are happy with the arrangements. The quotes must include fresh risk assessments for each premises and comply with the schedule of work required to satisfy current legislation.

It was **resolved** that the Chair and Clerk would review all quotations on receipt and inform the preferred contractor for the commencement of the new contract on the 1st October, 2021.

i) Saron Pavilion

The annual boiler service had been completed by Amman Heating Services at a cost of £130.00.

j) Defibrillator financial support

Councillor Ll. Hindley had been approached to see whether the Council would be able to partially fund a new defibrillator for the children's nursery at Penygroes. It was **resolved** that a request for a council grant should be submitted to the Clerk for consideration at September's finance committee.
