Declarations of Interest

Councillor R.A Davies declared an interest on Minute 924 - Floodlight refurbishment at Llandybie park / Tennis courts - as Secretary and Treasurer of Llandybie Tennis Club .

Projects for 2022-23

a) The Clerk reported that he had received a number of requests for suitable projects during the next financial year. It was agreed to **recommend** to Council that the projects listed below be considered as part of the Community Development programme for 2022-2023.

- 1) Refurbishment of Bonllwyn park
- 2) Hendre Road pavement, Capel Hendre
- 3) Park benches at Llandybie park
- 4) Scattering of wild flower seeds at various locations
- 5) Floodlight refurbishment at Llandybie park / Tennis courts
- 6) Bug Hotels, Bat Houses and Bird boxes

b) It was further **recommended** that a potential project for the installation of electric car charging points at Penygroes be confirmed as suitable to Carmarthenshire County Council as the project was at nil cost to the Community Council. The preferred location for the stations had been identified as the car park of Penygroes Welfare Hall, and the proposal carried the support of the hall committee.

c) It was **recommended** that a sum of £20000 should be allocated to Earmarked reserves to support Caerbryn Welfare Association in replacing the children's park at Caerbryn. Grant applications will need to be submitted by the hall committee to secure funding with the Council agreeing to provide funding once all other funding was in place

d) It was further **recommended** that a project to replace damaged fencing at the children's play area in Saron park should proceed during this financial year at a cost of £8100. The new fence would also extend along the boundary of the car park and comply with the lease agreement to provide and maintain in good repair substantial fences as agreed with the adjoining landowner.

e) Proposals for traffic calming measures on four roads in the area were worthy of further consideration and it was **recommended** that the Clerks should contact Carmarthenshire County Council to establish volume and average speeds along these roads.

f) It was further **recommended** that £30000 be earmarked for the maintenance and repair of the parks.
