#### Application No. PL/09334

- Cilyrychen Quarry, Llandybie, Ammanford, SA18 3JG
- Discharge of Conditions 11, 19, 29, 30 31 and 32 on PL/02167 (Land Contamination, Air Quality Monitoring, Conservation Management Plan, Lime Kiln Analysis, Lime Kiln Monitoring, Landscape and Ecological Management Plan)

**Observations;** The committee offered the observation that the key reports were draft and the officers of the County Council had commented on this, so it was difficult to offer a definitive observation, however, the viewpoint of the committee was that there was in recent years reports of the leaking of waste into the Afon Gwenlais and subsequently River Marlais and this could not be tolerated by the community if the work starts at this site, it would need to be monitored strictly.

Further observations where that the dust and noise reports seemed a little vague and again caution and strict monitoring of this to protect the health of residents in proximity should be applied.

Finally there were observations that the work of restoration on the Kilns should also be monitored and carried out sympathetically to preserve the integrity of the heritage and the bat community that lives within them.

**Observations;** The committee felt that it as was inappropriate to have signage that might offer a problem to road users at this busy junction.

- Repairs and adaptation into a holiday cottage with storage on the ground floor and interpretation centre in the attached open fronted lean to building

**Observations;** The committee offered the observation that the restoration of such an important heritage site should be welcomed, and the creation of jobs and provision of an accommodation opportunity for visitors to the area should be welcomed, especially with the low amount of car parking spaces required.

- New bulk powder silo

**Observations;** The committee wanted noted that a condition should be put on the application that the new junction and entrance be used by the company, this was not entirely the case at the moment with dust, noise and traffic complaints noted from residents by Councillors.

But it would support the application with this condition as the business was a provider of much needed jobs in the area.
