**Discussion and updates on Banc Y Ddraenen and 106 monies.**

The Clerk explained that he has met with Carmarthenshire County Council and the Planning Application to offer 106 money against the cost of the 'Nature Reserve Aspiration' is being challenged, there also an embargo on developments in the Llanelli Area on soil nutrients and leakage to water courses being damaged by building developments, the Clerk will be discussing alternative ways to get the Nature Reserve project started.

**Saron Park Zip Wire Project**

The project will start at the end of January to council has now been offered 106 monies to cover 100% the cost of £18,443 plus vat (vat not claimable).

**Penygroes Park Zip Wire Project**

The Clerk is waiting for the County Council to confirm eligibility of the same 106 monies for the Saron area for Penygroes Park, the project will however start at the end of March.

**Blaenau Park Zip Wire Project**

The Clerk is also waiting for 106 confirmations from the Saron 106 monies towards the cost, however this project will start at the beginning of April. This will be part paid by the 106 funds of £37,226 for all three projects.

**Gates at Penygroes Park**

The project is due to be completed on the 13<sup>th</sup> of January. The delay was due to weather and Christmas.

**Update on lease to Saron Juniors Football Club**

A request to take over the lease agreement which has been agreed by our Full Council to be explored, Carmarthenshire County Council emailed the Clerk to say they have no objections. Currently the club are preparing an agreement for us to consider once the Clerk has sought the advice of our solicitors CCW Law to check the detail of the proposal and the present to Full Council.

**Morgan Marine Tree Planting project at our parks**

The Clerk is waiting for Morgan Marine to agree a site visit to agree dates and locations for planting and ask for volunteers to help with the tree planting at 5 parks.

**Clerk will introduce Coed Lleol scheme at Banc Y Ddraenen**

As per item 1 the Clerk explained that he was in discussion with Coaed Lleol and Carmarthenshire County Council for a fully funded scheme that has been offered with 6 days of Community Activity to do works on the Nature Reserve Area, the Clerk will use this opportunity to 'kick starting' the Nature Reserve project.

**General update on Rights of Way.**

The Clerk led discussion on how to promote and use the footpaths as per our Section 6 Biodiversity Report which was presented at the meeting, ideas discussed included flyers on walks and an interactive online map that links to phone apps for walkers and hikers.

**Discussion on solar on toilets, parks and motion sensor lighting**

The Clerk explained that he has arranged to meet our electrical contractor on site next week to get a formal brief in place.

**Update on the green heating solutions for Llandybie Pavilion.**

The Clerk explained that despite many requests the Clerk is still waiting for the energy report promised before Christmas on guidance to write a brief to supply to contractors. He explained that he would update all Councillors on progress at the next Ordinary Meeting.

**Floodlights strategy at Llandybie and Capel Hendre**

The explained that specialist company have advised the Clerk on how to address a long-term solution to floodlights, the Clerk is researching grants to be applied for and a tender brief and will look at the project in the coming year.

**Adoption parcels of land for tree planting/Penygroes.**

The Clerk explained that he is waiting for a formal reply from Carmarthenshire County Council as there is a bit of confusion on ownership of the land at Norton Road Penygroes.

**Section 6 Biodiversity Report (Circulated)**

The Clerk discussed the action points to be overseen by the Green Spaces committee and explained that he had been offered consultancy and training through the One Voice Wales Biodiversity Team to take the report to the next stage and put an action plan in place, he will report on progress at the next Green Spaces Committee.
